## DETAILS:

**Shambala Wild Animal Protection Act of 2000** was a bill named after actress Tippi Hedren's personal exotic pet collection ranch "Shambala". When her movie Roar flopped, she had too many animals that she was not able to feed. She incorporated as a non profit 'sanctuary', so the public could pay for her pets through donations. Tippi decided to push for heavy regulations on others by introducing her pet bill. She made sure her own facility would be exempt from this extremely bureaucratic legislation that would micromanage many species of exotic and wild animals.

The original **Captive Wildlife Safety Act** included bears and big cats and their hybrids (cougar, leopard, jaguar, cheetah, tiger, lion, liger, tigon). Final version that passed and was signed into law by President George W Bush affects big cats only. This bill makes it a felony for pet owners to transport their pets across state lines for any reason. There are NO exceptions for veterinary treatment or in case of a natural disaster, or other emergency. It forces owners to get rid of their pets when moving to a different state.

**Captive Primate Safety Act** didn't pass yet. It affects all non human primates (apes and monkeys). It is similar to the big cat version, except that the latest version would allow owners to transport their pets across the state lines for veterinary treatment. It also allows for placement of the animals to a legally designated caregiver in the event of the death of the owner.

**Haley's Act** would make it illegal for the general public to touch any big cat, regardless of size and age. Current regulations forbid the public to interact without barriers with big cats over 4 months old, Haley's act would ban all ages. The bill is named after young girl Haley who died while posing with a full grown tiger for her graduation picture. This was a violation of existing rules and the exhibitor was closed down as a result. Haley was ILLEGALLY posed with an adult cat.

**The Non-Native Wildlife Invasion Prevention Act** would create 'Prohibited' and 'Approved' species lists. Usually with bills, if the species is not on prohibited list, it is legal by default. In the case of HR 6311, for the species to be legal, it would have to be absent from the PROHIBITED list, and at the same time be on the APPROVED list. All others would be ILLEGAL by default. To be listed on the Approved list, proof must be provided that it will never harm the environment. This is as insane as asking the person buying a new car that they will never get into a car accident. This bill must be killed.
