This investigation was started by a complaint of Michael Healy taking animals from the Brevard county animal control and selling them. I spoke to Mr. Healy who advised me that he took the animals in question to different rehab. centers. Mr. Healy stated that the animals were placed in his name instead of the facility because he took possession of them for transport. Mr. Healy is licensed by the Florida Fish and Wildlife Commission to sell exotic animals. Therefore there is no violation and this case is closed.
