PLAINTIFFS' ORIGINAL PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

NOW COMES, ANIMAL SANCTUARY OF THE UNITED STATES DBA WILD ANIMAL ORPHANAGE, and CAROL ASVESTAS hereinafter called Plaintiffs complaining of and about R.G. GRIFFING DBA R.G. GRIFFING PUBLICATIONS, SAN ANTONIO LIGHTNING NEWSPAPER AND SAN ANTONIO LIGHTNING.COM, hereinafter called Defendant, and for cause of action shows unto the Court the following:

I.

Plaintiffs intend that discovery be conducted under Discovery Level 2.

II.

Defendant, R.G. GRIFFING DBA R.G. GRIFFING PUBLICATIONS, SAN ANTONIO LIGHTNING NEWSPAPER AND SAN ANTONIO LIGHTNING.COM, may be served with process at the following address:

III.

At all times mentioned, Defendant's newspaper was, and still is, doing business as a publisher and disseminator of news and current events, and was and now is, publishing and circulating a internet newspaper in San Antonio, Bexar County, Texas, known as San Antonio

Lightning. The newspaper has a circulation and is read by persons and citizens of the area in which it is published and circulated in the entire United States on the worldwide internet.

IV.

At all times mentioned, Defendant, R.G. GRIFFING, was, and still is, the president and publisher of defendant newspaper. Defendant, R.G. GRIFFING, is managing editor, and is a news reporter for the paper. Defendant was, at all times material, acting in the course and scope of his duties of defendant newspaper.

V.

On or about January 6, 2009, Defendant published on his internet website/ virtual newspaper an article entitled "The Lyin' Queen." Said article contained libelous statements regarding plaintiffs, ANIMAL SANCTUARY OF THE UNITED STATES DBA WILD ANIMAL ORPHANAGE, and CAROL ASVESTAS. A copy of the article is attached to as Exhibit "A" and incorporated herein. Further, on or about July 16, 2009, Defendant published on his internet website/virtual newspaper (2) two articles entitled "Vivi, the SA Tiger is Dead" and where is Vivi's Body?" both articles contained libelous statements regarding plaintiffs, ANIMAL SANCTUARY OF THE UNITED STATES DBA WILD ANIMAL ORPHANAGE, and CAROL ASVESTAS. A copy of the articles is attached to as Exhibit "B" and incorporated herein. On or about July 20, 2009, Defendant published on his internet website/virtual newspaper an article entitled "Tiger, Tiger Burning Dim." Said article contained libelous statements regarding plaintiffs, ANIMAL SANCTUARY OF THE UNITED STATES DBA WILD ANIMAL ORPHANAGE, and CAROL ASVESTAS. A copy of the article is attached to as Exhibit "C" and incorporated herein.

VI.

The libelous articles upon which this cause of action is based were seen and read by readers of the San Antonio Lightning on the day of circulation in the City of San Antonio, County of Bexar

and throughout the entire State of Texas and United States.

VII.

Defendant was negligent in publishing the article complained of in this petition. Defendant knew or should have known in the exercise of ordinary care that the article was false and injurious to plaintiffs. The articles printed, published, and circulated by Defendant's internet newspaper, as set forth above, of and concerning Plaintiffs, were purely fictional and untrue. Defendant failed to investigate the truth of the facts published concerning Plaintiffs, ANIMAL SANCTUARY OF THE UNITED STATES DBA WILD ANIMAL ORPHANAGE, and CAROL ASVESTAS, and failed to make any reasonable inquiry and was grossly negligent in such failure to inquire into the truth of the facts so published concerning Plaintiffs, ANIMAL SANCTUARY OF THE UNITED STATES DBA WILD ANIMAL ORPHANAGE, and CAROL ASVESTAS. The falsity of the abovedescribed articles would have been disclosed to Defendant had Defendant made any proper or reasonable inquiry concerning the facts published. The articles were printed, published, and circulated by defendant with such reckless disregard and carelessness as to their truth or falsity as to indicate and utter disregard of the rights of Plaintiffs, and the consequences of defendant's actions, maliciously, negligently, and inexcusably exposing Plaintiffs to public hatred, contempt, and ridicule, and impeaching Plaintiffs' honesty, integrity, virtue, and reputation and have caused Plaintiffs substantial injury and damage including, but not limited to, the fact that as a direct and proximate result of Defendant's acts, Plaintiffs, ANIMAL SANCTUARY OF THE UNITED STATES DBA WILD ANIMAL ORPHANAGE, and CAROL ASVESTAS has seen charitable contributions decline.

VIII

Furthermore, Defendant published the article either knowing that it was false, or with heedless and reckless disregard for whether it was false and without any factual basis for the article.

Publication of libel on its face with such reckless disregard for the truth or falsity of the statements made constitutes actual malice on the part of the Defendant newspaper, Defendant president and publisher, Defendant managing editor, and Defendant news reporter, R.G. GRIFFING DBA R.G. GRIFFING PUBLICATIONS, SAN ANTONIO LIGHTNING NEWSPAPER AND SAN ANTONIO LIGHTNING.COM.

IX.

As a direct and proximate result of Defendant's false and libelous statements, Plaintiffs, CAROL ASVESTAS, has endured shame, embarrassment, humiliation, and mental pain and aguish. Additionally, Plaintiffs is and will in the future be seriously injured in her good name and reputation in the community and exposed to the hatred, contempt, and ridicule of the general public, as well as of her friends and relatives. The publishing of the article complained of constitutes libel on its face, and such article is libelous and actionable, pursuant to Section 73.001 of the Civil Practice and Remedies Code. Plaintiffs, ANIMAL SANCTUARY OF THE UNITED STATES DBA WILD ANIMAL ORPHANAGE, and CAROL ASVESTAS, therefore, claims general damages in a sum in excess of the minimum jurisdictional limits of the Court.

X.

As a proximate result of the libelous material disseminated by the Defendant, Plaintiffs have suffered damages in a sum in excess of the minimum jurisdictional limits of the Court.

XI.

Defendant's publication of the libelous article complained of in this petition was done with an entire want of care and was done with conscious indifference to the rights and welfare of Plaintiffs. Plaintiffs, ANIMAL SANCTUARY OF THE UNITED STATES DBA WILD ANIMAL ORPHANAGE, and CAROL ASVESTAS, therefore, are entitled to recover exemplary

damages. Accordingly, Plaintiffs sue for exemplary damages in a sum in excess of the minimum jurisdictional limits of the Court.

WHEREFORE, Plaintiffs request that defendants be cited to appear and answer, and that on final trial Plaintiffs have:

- 1. Actual damages in a sum in excess of the minimum jurisdictional limits of the court.
- Damages, as set forth in this petition, in a sum in excess of the minimum jurisdictional limits of the court.
 - 3. Prejudgment interest as provided by law.
- 4. Exemplary damages in a sum in excess of the minimum jurisdictional limits of the court.
 - 5. Postjudgment interest as provided by law.
 - 6. Cost of suit.
 - 7. Such other and further relief to which Plaintiffs may be justly entitled.


Embarrassed PETA Bails; More Animals Vanishing

More animals are missing, more money is unaccounted for, and State and Federal authorities continue to probe the activities of Carol Asvestas of Animal Sanctuary of the United States, dba The SA area Wild Animal Orphanage (WAO).

The latest scandal involves the radical animal group PETA, which claimed a major victory by "saving" six rhesus macaques sold to New York University (NYU) for invasive brain experiments.

Those animals, and \$40,000, were instead sent to Carol Asvestas of the Bexar County based WAO.



Asvestas has been at the center of a growing firestorm, in which sources and others involved or aware of bad practices at the "sanctuary" say animals are routinely neglected, poorly fed and generally abused.

PETA (People For The Ethical Treatment Of Animals) used the monkeys for publicity sake, and trumpeted the "victory" when the animals headed to the WAO. They NEVER followed up.

The local and national media simply assumed that the animal compound was legit, and embraced Asvestas as a saint.

Far from it.

It appears she has been bilking concerned animal lovers across the nation of donation money and trust and the animals as well.

Uncounted and unaccounted for beasts - pigs, dogs, exotic cats and other wildlife have vanished at an alarming rate. Mass graves have been reported on land controlled by Asvestas as well.

After hearing from thousands of concerned people, NYU announced that it was sending the monkeys to a sanctuary. Wanda, Holly, Jada, Sophie, Samantha, and Lilly are now living together in a group at the sanctuary and will soon be introduced to the other monkeys at the facility. Kally Guillermo, Director Laboratory Investigations Department

PETA was quick, when informed of this series, to distance itself from WAO.

In a prepared statement a spokesperson said:

PETA had nothing to do with choosing a sanctuary for these monkeys. Lehman sold them to NYU for use in invasive brain experiments. Lehman had previously promised that the monkeys would be placed in sanctuary so PETA approached both Lehman and NYU and asked them to abide by the experimental protocol and retire the monkeys. NYU chose the sanctuary without consulting PETA. PETA did not contribute money. We don't know how much NYU/Lehman provided.

Then they made their email getaway.


