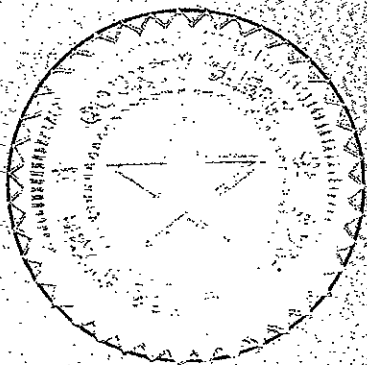

- 2) AN APPLICANT MAY REQUEST A JUDGE OF A COURT WITH JURISDICTION IN FAMILY LAW CASES, A JUSTICE OF THE SUPREME COURT, A JUDGE OF THE COURT OF CRIMINAL APPEALS, A COUNTY JUDGE, OR A JUDGE OF A COURT OF APPEALS FOR A WRITTEN WAIVER AS PROVIDED BY SUBSECTION (c), SECTION 2.204, TEXAS FAMILY CODE.

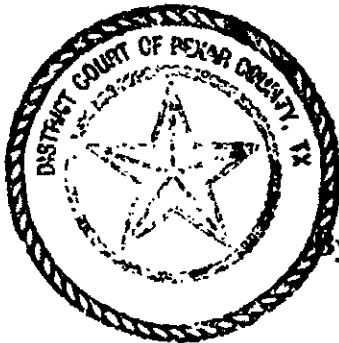
